This agreement (“**Agreement**”), dated as of \_\_\_\_\_, 20\_\_ (the “**Effective Date**”), is between Long Mountain Long Dogs and \_\_\_\_\_ (“**Buyer**”). Buyer agrees to place a \$500.00 deposit (“**Deposit**”) on a dachshund puppy from Long Mountain Long Dogs.

1. Buyer acknowledges that the Deposit is non-refundable in all circumstances, including but not limited to if Buyer decides s/he does not want or is no longer able to take the puppy. Upon receipt of the Deposit, Long Mountain Long Dogs (LMLD) agrees to hold the puppy for Buyer until it has been weaned and is ready for pick up. All payments under this Agreement shall be made in US dollars and paid to Breeder via Good Dog. <https://pay.gooddog.com/long-mountain-long-dogs>
2. Buyer further acknowledges and agrees that (a) Breeder cannot control unforeseen health emergencies/conditions and will refund deposit if puppy cannot be placed; (b) the Deposit guarantees the puppy that Long Mountain Long Dogs and buyer have agreed upon, as detailed above; (c) LMLD cannot and does not guarantee any specific qualities of the puppy when it becomes an adult.
3. If Buyer pays the Deposit, then later decides s/he does not want the puppy for any reason, LMLD is not required to refund the Deposit. If, however, LMLD is able to sell the puppy to another buyer within a reasonable amount of time after Buyer notifies LMLD of his/her decision, LMLD may (in its sole discretion) refund the Deposit to Buyer.
4. LMLD and Buyer agree that (a) the Deposit shall be applied to the final purchase price of the puppy and (b) the remaining balance will become due before the puppy is picked up/shipped and/or ownership is transferred from LMLD to Buyer. The total purchase price for the puppy is \$\_\_\_\_\_. The foregoing purchase price does not include any delivery or shipping charges.
5. **Governing Law.** This Agreement, and all matters arising out of or relating to this Agreement, shall be governed by and construed in accordance with the laws of the State of West Virginia without regard to the conflicts of laws provisions thereof.
